Delegations Policy

PURPOSE

Delegations within the University are intended to achieve three objectives:

- to ensure the efficiency and effectiveness of the University's administrative and financial processes;
- to ensure that the appropriate officers have been provided with the level of authority necessary to discharge their responsibilities; and
- to ensure internal controls are effective.

By this policy Council:

- Delegates to the Vice-Chancellor or to Academic Board certain functions and powers;
- Authorises delegations made by the Vice-Chancellor of Council functions and powers;
- Authorises University staff to enter into certain documents on behalf of the University;
- Authorises the Vice-Chancellor to undertake certain actions.

By this policy the Vice-Chancellor delegates to the staff members of the University certain functions and powers of the Vice-Chancellor.

1 LEGISLATIVE REQUIREMENTS

- 1.1 Sections 285(1) and 286(1) of the Education and Training Act 2020 (the *Act*) enables Council, by writing to delegate to the Vice-Chancellor or to any committee appointed under section 283(4) of the Act, any of its functions or powers, (except the power to appoint a Vice-Chancellor).
- 1.2 By section 286(5) of the Act the Vice-Chancellor or Academic Board may, with the prior written approval of Council, subdelegate such of those functions and powers as the Council approves, to a staff member of the University.
- 1.3 Section 295(1) of the Act enables the Vice-Chancellor by writing to delegate to the Academic Board or to any staff member of the University any functions or powers of the Vice-Chancellor including those functions or powers delegated to the Vice-Chancellor by Council.

- 1.4 By section 296(5) of the Act the Academic Board or a staff member of the University may, with the prior written approval of the Vice-Chancellor, subdelegate such of those functions or powers as the Vice-Chancellor approves to any other staff member of the University.
- 1.5 A delegation by the Council or by the Vice-Chancellor does not affect or prevent the performance by them of any function or power or of the responsibility for any actions of any person acting under the delegation (section 296(3) and 286(3) of the Act).
- 1.6 A delegation is revocable in writing at will (section 296(1) and 286(6) of the Act).

2 COUNCIL DELEGATIONS

- 2.1 Pursuant to section 285 of the Act 2020, Council delegates to the Vice-Chancellor or to Academic Board those powers and functions more particularly described in Schedule 1.
- 2.2 Subject to the provisions of sections 285 and 286 of the Act, and in accordance with Schedule 1, Council approves the delegation of those powers and functions by the Vice-Chancellor to staff members of the University and that person may exercise or perform those powers or functions in like manner and with the same effect as the Vice-Chancellor could have exercised or performed them.

3 COUNCIL AUTHORISATIONS

- 3.1 Pursuant to section 273(1) of the Act, Council authorises certain staff members of the University to execute certain documents on behalf of the University being those more particularly described in Schedule 2(a).
- 3.2 Subject to the provisions of sections 285 and 286 of the Act and in accordance with sections 297, 255 and 256 of the Act, Council authorises the Vice-Chancellor to undertake certain actions being those more particularly described in Schedule 2(b).
- 3.3 Pursuant to sections 295 and 296 of the Act and in accordance with Schedule 2(b) Council approves the delegation of certain authorities and functions by the Vice-Chancellor to staff members of the University.

4 VICE-CHANCELLOR MANAGEMENT DELEGATIONS

4.1 Pursuant to sections 295 and 296 of the Act, the Vice-Chancellor delegates to certain staff members of the University, certain management powers and functions of the Vice-Chancellor being those more particularly described in Schedule 3.

DEFINITIONS

Capital Expenditure (Capex)

A purchase of an item of property, plant or equipment, or the subsequent development or improvement of an existing asset at a cost exceeding the minimum capitalisation level that derives a future benefit to the University.

Delegation

Delegation is the authority granted by the Council to University staff to make commitments to authorise documents, functions and/or payments on behalf of the University. All

delegations must be in accordance with University policy and within approved budget and authorised delegation.

Delegates

Deputy Vice Chancellors, Deans, Assistant Vice Chancellors, Pro Vice-Chancellors, Group Director People and Culture reporting directly to the Vice Chancellor Others - Senior Managers reporting directly to the Deputy Vice Chancellors, Deans, Assistant Vice Chancellors, Pro Vice-Chancellors, Group Director People and Culture, including Deputy and Associate Deans, Heads of Schools and Group Directors

Operating Expenditure (Opex)

Expenditure incurred in the course of day-to-day University operations.

Scope This policy applies to all staff and all University operations.
